#### **Practice:**

## 1. Awareness-raising

- ATECI sub-committee on the Arts is established
- ATECI is a member and contributor to ETAI
- ATECI provision in CPD in the Arts is being documented and will be updated annually
- ATECI is proposing that
  - Centres identify local artists who are working in schools, with the Centre or any school community initiatives with a view to establishing a register, which is accessible to the Network for teacher/artist collaborations. This can be achieved through discussion with the local Arts Officer, schools, various organisations under the auspices of the Arts Council. It may be necessary to establish a set of criteria/guidelines to formalise this approach. Garda vetting is also a consideration.
  - Centres review their investment in the Arts aspect of their Local CPD provision and to designate a % of the Budget to this Curriculum area in the context of support for the implementation of the Curriculum and with reference to the "Arts Rich School" aspect in particular.
  - Centres review the nature of the provision being made, short -term, medium- term, long-term engagements, the Arts area being supported, the gaps in provision, disengaged schools etc.

- Centres contact their local Arts Officer regarding sources of funding e.g. residencies, becoming a "nexus" for Arts Support for schools etc.
- Delegates to The Education Conference are chosen from select schools i.e. schools that will feature in the summer course CPD
- -"Creative School" /Other projects —one from each region -which reflect artist/teacher collaboration might be showcased at the Education Conference (virtually or otherwise)
- The Training of Trainer database is circulated to centres and is reviewed in the context of the capacity already existing in the System/in Centres.

# 2. Teacher/Artist: Artist/ Teacher Professional Development:

It is proposed to design a summer course which will take place in 2014 for Primary Teachers only (year 1) in each Education Centre. DES has requested ATECI to present a variety of models, which would feature teacher/artist collaboration. Each Centre has discretion over the nature of the initiative at local level i.e. this is not a "national" programme.

A proposed model (Draft 1) (It is understood that Dr. Alan Wall has cleared this provision with TES. Due regard should be given to the Creative Schools Award, Creative Engagement and the concept of the Arts Rich school when considering any model. The context of the CHARTER is of obvious relevance.)

- Each Centre selects the school /cluster of schools/existing community of practice & the artist before 1 November. This will have been considered in the context of delegates to the ATECI Education Conference also
- Specific Selection criteria will be developed to support Centres in this regard. Criteria will
  have due regard to Systemic priorities such as SSE,L & N, Creativity and demonstrate
  commitment to building leadership capacity, building community and value a whole school
  approach to Curriculum implementation and the sharing of practice. The school should also
  be open to cultural change.
- Principals/Potential Teacher Leaders from the selected school/school clusters/cops and selected artists are brought together regionally/nationally to begin the process of cocreation i.e. the plan
- Parallel to this the Training of Trainer Programme is being designed (Some teacher leaders will be involved in the design also). This must be undertaken in Term 2 and will also involve the design of the summer course.
- Regional Meeting No. 2 will take place early in Term 3 to finalise the Course.
- These "Co-Creators" will deliver the summer course. The course will be monitored carefully and evaluated.
- A report will be produced, which will include dissemination of the Learning and Planning an implementation programme in the schools in Year 2014-2015.
- Opportunity for review will also be considered.

• The sharing of Practice on the **Portal** should also be kept in mind.

Centres will be asked to respond to this draft and to put other models and ideas forward. Many other models exist both in Ireland and in other jurisdictions.

- **3.** Any relevant material will be posted on the ATECI web-site (private members). Of particular relevance are the Artists~Schools Guidelines especially PIE Chart page 17
- 4. **PALS** Pilot has been initiated in Regions 1 & 2 of the Network and the documentation has been circulated.
- 5. Links have been established with the "Virtually There" project and the information will be disseminated to centres for consideration at the September meeting. Some Centres are already interested in developing this work. It is suggested that this project could be "virtually" introduced at the Education Conference.
